INTRODUCTION

As people age, they often face challenges in finding activities and social spaces that meet their needs and interests. This situation is exacerbated for those with disabilities, as many entertainment and networking options are not designed with inclusion in mind.

PROBLEM

There is a shortage of clubs, groups, associations, communities, etc., that specifically cater to people over 30 years old and, at the same time, are inclusive for people with disabilities. This results in the exclusion of an important demographic from opportunities for socialization and personal development.

SOLUTION

Create a space that offers activities and events designed for people 30 years and older, with or without disabilities.

30+Inclusive is committed to creating a welcoming and safe space where all individuals feel valued and appreciated.

Through partnerships with organizations and companies dedicated to inclusion, the organization aims to expand its reach and offer meaningful opportunities to its members. HOW DOES ENTREPRENEURSHIP ARISE?

WHAT PROBLEMS AROSE?

- Shortage of inclusive social spaces for people over 30 years old.
- Exclusion of people with disabilities from recreational and social activities.
- Limited networking and personal development opportunities for people in this age group.
- Lack of awareness about the importance of inclusion in society.

WHY DID WE CHOOSE **ACCESSIBILITY?**

We chose to address the issue of the exclusion of people over 30 years old in social spaces and recreational activities because it was seen as an underserved need in the community. Additionally, the opportunity to promote the inclusion of people with disabilities was identified at the same time.



WHAT SOLUTIONS DID WE **CONSIDER?**

- Create a social club exclusive for people over 30 years old.
- Develop a digital platform to connect people in this age group and organize events.
- Offer inclusive activities that address the needs and interests of this demographic.
- Establish partnerships with companies and organizations committed to inclusion.

WHY DID WE CHOOSE THIS **SOLUTION?**

The decision to create 30+Inclusive as a solution was made because it offers a comprehensive response to several problems identified during brainstorming. The organization or club provides an inclusive social space, diverse activities, and a digital platform to connect its members, thus addressing social exclusion and promoting diversity and inclusion within the community.



















Theoretical training on green, social, and digital entrepreneurship.

Completing the theoretical course and understanding how to create or how an entrepreneurial venture emerges.




ACHIVEMENTS

While the primary focus of 30+Inclusive is social, the organization can also promote environmental awareness through activities and events that address topics related to sustainability and environmental care.

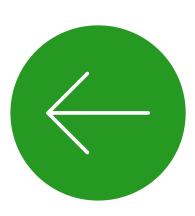
CONCLUSIONS
